

Short Description	Hastings Technology Metals Limited (Hastings) proposes to develop the Yangibana Rare Earths Project (the Proposal), located approximately 270 km east-northeast of Carnarvon, in the Upper Gascoyne region of Western Australia (WA). The Proposal will involve mining above and below the ground water table, on site processing of ore, water abstraction, and transport via road to Geraldton port for export.
